

2020 - 2021 Contract Time Application

acac is excited to give our full-facility members the opportunity to reserve a court for the entire 2020/21 indoor court season! Season court time is reserved for the same time and same day of each week during the season from October 19, 2020 through April 4, 2021.

You have until **October 23, 2020** to make any changes to your contract. After this date, a service charge of \$5 per player on the contract will be incurred to the court captain.

Charges will be split equally amongst all players (listed on back)

Billing & Appointment Procedures

1. In order to fill as many requests as possible, **acac** reserves the right to assign specific courts within the Indoor Center for all reservations. When special events are held at **acac**, we reserve the right to move players to another court or cancel your court for that day. If your court is canceled by **acac**, your group will receive up to four makeup passes to use.
2. The billing of court time will be calculated by multiplying the prevailing hourly court time rate by the number of weeks in the season for the day of the reservation.
3. Reservations for season court time will be charged in two installments, on Nov. 1 and on Feb. 1.
4. Any captain who pays their contract in full by Oct 14 will receive 3 **acac** guest passes. *Please remember that there is a 6 visit limit per year for guests*
5. **acac** reserves the right to decline requested court times for any reason deemed reasonable by **acac** management. Each application will be date stamped to confirm date received.
6. Although season court time cannot be cancelled, there may be times when a group is unable to play on a specific date. In the event this occurs, and the club is notified at least 24 hours in advance, **acac** will attempt to sell the court. If the court is sold, the court captain's account will be credited.
7. The captain should fill in all the names of the players on their contract on the back of this application. You should include any splits and method of payment. Bring this application to Lottery Night.
8. The captain is responsible for supplying the players' names and assuring that full payment for the contract is made.
9. There are no contract refunds. If a player in your contract is unable to play, it is the group's responsibility to refund that member.
10. Any changes to this contract after October 23 will result in a \$5/player fee on the contract.
11. If the club is closed for inclement weather, the captain will receive up to 4 individual "make-up passes" that their group may use. The make-up passes will expire one year from date of issue. Make-up passes should be booked using **acac's** normal booking system.
12. Signing this form is a commitment to the contract.
