

ACAC JOIN IN SEPTEMBER, WIN A YEAR FREE SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. PROMOTION PERIOD

The ACAC Join in September, Win a Year Free Sweepstakes ("Sweepstakes") begins September 1, 2026 at 12:00 a.m. Eastern Time and ends September 30, 2026 at 11:59 p.m. Eastern Time ("Promotion Period").

2. SPONSOR

The Sweepstakes is sponsored by ACAC Fitness & Wellness Centers ("Sponsor" or "ACAC").

3. ELIGIBILITY

The Sweepstakes is open to legal residents of **Virginia, Pennsylvania, and South Carolina** who are eighteen (18) years of age or older at the time of entry and who are eligible to hold an ACAC membership.

Employees of ACAC, and members of their immediate families or households, are not eligible to enter or win.

The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited.

4. PARTICIPATING MARKETS

The Sweepstakes will be conducted across the following four ACAC markets:

- Charlottesville, Virginia
- Richmond, Virginia
- Southeast, Pennsylvania
- Upstate, South Carolina

One (1) winner will be selected from eligible entries received in each participating market, for a total of four (4) winners.

Each entrant may participate in only one market for purposes of this Sweepstakes.

5. HOW TO ENTER

There are two methods of entry:

A. Join ACAC During the Promotion Period

An eligible individual who joins a participating ACAC location between September 1 and September 30, 2026 will automatically receive one (1) entry into the drawing for the ACAC market associated with the location joined.

B. Free Alternative Method of Entry

No purchase or membership is required to enter or win.

During the Promotion Period, eligible individuals may receive one (1) entry without purchasing an ACAC membership by emailing **socialacac@gmail.com** and providing their first and last name, email address, phone number, ZIP code, and participating ACAC market.

Free entries must be received no later than 11:59 p.m. Eastern Time on September 30, 2026.

Limit one (1) entry per person, regardless of method of entry. A membership purchase does not increase an entrant's chances of winning.

Incomplete, inaccurate, illegible, fraudulent, automated, or otherwise noncompliant entries may be disqualified at Sponsor's discretion.

6. WINNER SELECTION

Following the conclusion of the Promotion Period, Sponsor will randomly select one (1) potential winner from all eligible entries received in each participating ACAC market.

Four (4) winners will be selected in total.

Potential winners will be contacted using the contact information provided to ACAC and may be required to verify eligibility and complete any documentation reasonably required by Sponsor before receiving the prize.

A potential winner **must respond within five (5) business days of Sponsor's initial notification.** If a potential winner cannot be contacted, fails to respond within five (5) business days, is determined to be ineligible, declines the prize, or fails to satisfy the requirements of these Official Rules, Sponsor may select an alternate winner from the remaining eligible entries for that market.

7. PRIZE

One (1) prize will be awarded in each participating ACAC market, for a total of four (4) prizes.

Each winner will receive:

One (1) 12-month ACAC Fitness Only individual membership.

The prize includes base membership dues for a Fitness Only individual membership for twelve (12) consecutive months.

If the winner joined ACAC during the Promotion Period, the prize will be applied as a waiver, refund, or credit, as determined by ACAC, toward twelve (12) months of the winner's eligible individual Fitness Only membership dues.

If the winner entered without purchasing a membership and is not an ACAC member at the time of the drawing, the winner will receive a 12-month Fitness Only individual membership, subject to ACAC's standard membership eligibility requirements and membership terms.

Prize does not include enrollment or joining fees, membership upgrades, additional household or family members, add-ons, personal training, programs, spa or recovery services, products, or other separately charged goods or services unless expressly stated by Sponsor.

Approximate Retail Value ("ARV"): \$1,200 per prize. Total ARV of all four prizes: \$4,800.

The prize is non-transferable, may not be redeemed for cash, and may not be substituted by the winner. Sponsor reserves the right to substitute a prize of equal or greater value if necessary.

All applicable federal, state, and local taxes associated with acceptance or use of the prize are the sole responsibility of the winner.

No winner will be required to attend a sales presentation, tour, consultation, seminar, or similar promotional activity as a condition of receiving the prize.

8. ODDS OF WINNING

Odds of winning depend upon the number of eligible entries received within each participating ACAC market during the Promotion Period.

A purchase or membership does not improve the odds of winning.

9. WINNER NOTIFICATION AND PRIZE ACCEPTANCE

Potential winners will be notified using the email address and/or telephone number associated with their entry.

Potential winners must respond to Sponsor's initial notification **within five (5) business days** and may be required to provide proof of identity and eligibility and to complete an affidavit or declaration of eligibility, liability release, tax documentation, and/or other documentation reasonably requested by Sponsor.

Failure to respond within five (5) business days of Sponsor's initial notification or failure to satisfy the requirements of these Official Rules may result in forfeiture of the prize and selection of an alternate winner.

Once a winner has been verified as eligible and has satisfied the applicable requirements of these Official Rules, Sponsor will award the prize within ten (10) days, at no cost to the winner and without requiring any additional purchase or financial obligation.

A winner is not required to attend any sales presentation, tour, consultation, seminar, or similar promotional activity as a condition of receiving the prize.

10. GENERAL CONDITIONS

By participating, entrants agree to comply with these Official Rules and the decisions of Sponsor regarding the administration of the Sweepstakes, which shall be final to the extent permitted by law.

Sponsor reserves the right to disqualify any individual who tampers with the entry process, attempts to obtain entries through fraudulent or improper means, violates these Official Rules, or otherwise interferes with the fair administration of the Sweepstakes.

Sponsor reserves the right, subject to applicable law, to cancel, suspend, modify, or terminate the Sweepstakes if fraud, technical failures, unauthorized intervention, or other circumstances beyond Sponsor's reasonable control materially affect the integrity or proper administration of the Sweepstakes.

11. LIMITATION OF LIABILITY

To the fullest extent permitted by applicable law, Sponsor is not responsible for lost, late, incomplete, inaccurate, misdirected, corrupted, or otherwise invalid entries; technical or communications failures; or other circumstances beyond Sponsor's reasonable control that may affect participation in the Sweepstakes.

Nothing in these Official Rules is intended to exclude or limit any right or liability that cannot legally be excluded or limited.

12. PRIVACY

Information submitted in connection with the Sweepstakes will be handled in accordance with ACAC's applicable privacy practices and may be used to administer the Sweepstakes, verify eligibility, contact potential winners, and award prizes.

Any additional marketing communications will be handled in accordance with applicable law and ACAC's privacy practices.
